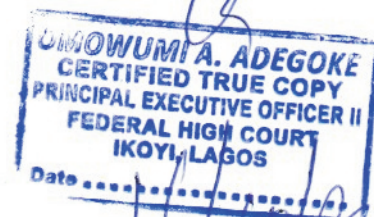

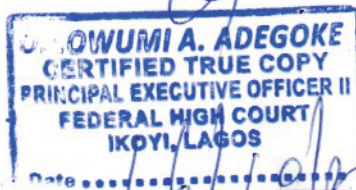


ORDER
